STROKE PLAY STATE CHAMPIONSHIP

Conducted by the Women's South Carolina Golf Association
Spring Valley Country Club, Columbia, South Carolina
September (13) 14-16, 2010



ELIGIBILITY: Open to any female amateur golfer who is a permanent legal resident of South Carolina for a minimum of six months prior to the championship, is a member of a Women's Golf Association which is a regular or associate member of the WSCGA, and has a current handicap index issued by the Handicap Program of the Carolinas. Also eligible, upon payment of \$35.00 individual tournament dues, are any women who receive a handicap index from the Handicap Program of the Carolinas and whose women's golf association is not a WSCGA member. If you are a transgendered individual, please contact the WSCGA office for the WSCGA policy and additional application procedures.

ENTRIES: **Entries open on July 27, 2010.** All entries must be filed on attached form and received by **5:00 p.m. on August 23, 2010.** The field will consist of 96 players. Handicap index limit for entering is 25.5. Entry fee includes tournament cart fees, club storage, range balls, dinner, luncheon, and prizes. Entries will be accepted based on handicap index from low to high. Entry fee is **\$165.00.** Notice of acceptance (or non-acceptance) will be e-mailed on or about August 25, 2010. Should a player's withdrawal notification be received by the Tournament Committee after the entry deadline, (August 23, 2010) only cart fees will be refunded. **No refunds will be made for a withdrawal after August 31, two weeks prior to the Championship.**

FORMAT: USGA Rules apply. Local Rules will be distributed at the tournament site. The Championship is contested at 54 holes of stroke play. Two sets of tees will be used, a Championship tee at approximately 5733 yards, and a State Tee at 5270 yards. **All Players with a 5.0 handicap index or less must play the Championship Tee.** Players are flighted after 36 holes of qualifying. The Championship Flight will consist of sixteen players with the lowest qualifying scores, plus all ties. Players must use golf carts.

RESTRICTIONS: Shoes with traditionally-designed spikes comprised of metal are prohibited. Players must be neat in appearance with respect to personal grooming and clothing.
